7 20-06-2022 Heard learned counsel for the petitioner and learned
Additional Public Prosecutor for the State.

From perusal of the office notes, it appears that
opposite party no. 2 did not found at the given address.

The petitioner apprehends his arrest in a case
registered for the offences punishable under Sections 420, 467,
468, 471, 120B of the Indian Penal Code.

It is submitted by learned counsel for the petitioner
that the petitioner is an innocent person and has committed no
offence. He further submits that the petitioner is ready to pay
Rs. 2 lakh to the complainant/opposite party no. 2.



Considering the facts that the petitioner is ready to pay the aforesaid amount to the complainant/opposite party no. 2, let the above named petitioner, be released on provisional bail for a period of four months, in the event of his arrest or surrender before the learned Court below within a period of six weeks from today, on furnishing bail bond of Rs.25,000/- (Rupees Twenty Five Thousand) with two sureties of the like amount each to the satisfaction of the learned Court below where the case is pending/successor Court in connection with Complaint Case No. 1028 of 2013, subject to the condition as laid down under Section 438 (2) of the Cr.P.C.,

Learned court below is directed to confirm the bail bond of the petitioner after depositing the aforesaid amount in the learned court below which will be released in favour of the complainant/opposite party no. 2 by the learned court below.
