ORAL ORDER

4 13-07-2022 In compliance of the order of this Court dated 20.06.2019, passed in C.W.J.C. no. 11674 of 2018, a sum of Rs. 18,61,450/- has been quantified to be the amount of arrears of salary outstanding to be paid to the petitioner, out of which a sum of Rs. 6,71,782/- was paid to the petitioner on 05.07.2022 and a sum of Rs. 11,89,668/- has been paid to the petitioner on



06.07.2022.

The learned counsel for the petitioner submits that the said outstanding salary paid to the petitioner for a period of about 21 years is not the full amount, according to the petitioner's calculation, hence the petitioner be granted liberty to approach the Director, Secondary Education, Government of Bihar, Patna for redressal of his subsisting grievance.

Accordingly, the present petition stands disposed off as not pressed, however with liberty to the petitioner to approach the Director, Secondary Education, Government of Bihar, Patna for redressal of his subsisting grievance.
