- 1.(a) That the present writ application is being filed on behalf of above named petitioners before this Hon'ble court for issuance of writ of certiorari for quashing/setting aside Notice Inviting Tender No.-06/2019-20 as far as it relates to Kiosk No. 1 & 2, Rajdhani Vatika, Patna issued by the Divisional Forest Officer, Patna Park Division, Patna as the same is contrary to clause -4 of the agreements dated 26.12.2018, which have been entered between the Divisional Forest Officer, Patna Park Division, Patna and Petitioners.

1.(b) That the petitioners are further praying before this Hon'ble Court for issuance of further writ of mandamus for directing/ commanding the respondent authorities specifically Divisional Forest Officer, Patna Park Division, Patna not to proceed and/or enter in an agreement with any third party.

1.(c) That the petitioner abovenamed are also praying before this Hon'ble Court for issuance of writ of mandamus for directing/ commanding the respondent authorities not to disturbed the petitioners till the disposal of present case.
