4 11-10-2022 Petitioner has prayed for the following relief(s):-

1. That this is an application for issuance of an appropriate writ, order or direction, particularly in the nature of writ of Mandamus, directing and commanding the respondent authorities, specially



respondent no. 2 to 4 to not auction the land of the petitioner situated at Mauja- Kasba Khas, P.S. No. 125, Ward No. 35, C.S. Khata No. 10, R.S. Khata No. 2, C.S. Plot No. 480, R.S. M.S No. 2242 and 2248(part) area 2 decimals within P.S: Sasaram District: Rohtas, which is going to be auctioned by the Punjab National Bank (Respondent no.2 & 3) on 06.01.2020;

Further the respondent-Bank be restrained to interfere in peaceful physical possession of the petitioner till disposal of the title suit no. 188 of 2019, which is pending in the court of Sub. Judge-XI, Sasaram (Rohtas).

To grant any other relief/reliefs for which the petitioner is found to be entitled.

On 27.09.2022, we had passed the following order:
