Parties are also personally present in Court and they filed an application for compromise being CAN 4 of 2022 in connection with C.O. 241 of 2016 praying for disposal of the application being C.O. 241 of 2016 filed under Section 24 of the Code of Civil Procedure as per the terms and conditions of settlement which they have annexed in the application (CAN 4 of 2022).

Perused the terms and conditions enumerated in the compromise application and I do not find the terms and conditions to be extraneous or illegal.
