The present revisional application was preferred by the petitioner who happens to be the accused by way of filing power/ vakalatnama through constituted attorney.

Petitioner's complicity in the present case is an accused. As such, I am not inclined to accept the manner in which the revisional application has been filed through the constituted power of attorney challenging the validity of the proceedings.

Accordingly, the present criminal revisional application being CRR 842 of 2018 is dismissed as not pressed.
