C.R.M.(A) 2346 of 2022

It is submitted by the learned Counsel appearing for the petitioner that the petitioner is the father-in-law of the victim. A criminal case had been registered against the victim by his wife. Subsequently, victim committed suicide. Ingredients of offence punishable under Section 306 of the Indian Penal Code are not disclosed in the facts of the case.

Learned Counsel appearing for the State opposes the prayer for anticipatory bail and submits victim was tortured and humiliated. As a result, he committed suicide.

We have considered the materials on record. A prior criminal case was registered against the victim alleging torture upon his wife. He did not leave behind any suicide note implicating the petitioner.

In view of the aforesaid facts, we are inclined to grant anticipatory bail to the petitioner.

Accordingly, we direct that in the event of arrest the petitioner shall be released on bail upon furnishing a bond of Rs.10,000/-, with two sureties of like amount each, to the satisfaction of the arresting officer and also be subject to the conditions as laid down under Section 438(2) of the Code of Criminal Procedure, 1973 and on condition that he shall appear before the court below and pray for regular bail within a period of four weeks from date.

This application for anticipatory bail is, thus, allowed.
