02. This matter is taken up through Hybrid arrangement (video conferencing/physical mode).

Heard learned counsel for the petitioner and learned counsel for the State.

This is an application under section 439 of Cr.P.C. in connection with Kumabharapada P.S. Case No. 304 of 2020 corresponding to T.R. Case No.52 of 2021 pending in the Court of learned Special Judge, Puri for offences punishable under sections 21(c), 25 and 29 of the N.D.P.S. Act.

The petitioner moved an application for bail before the Court of learned Special Judge, Puri, which was

rejected on 10.08.2021.

Learned counsel for the petitioner submitted that the petitioner is in judicial custody since 08.11.2020 and his earlier bail application in BLAPL No.9147 of 2020 was rejected as per order dated 02.06.2021 directing the learned trial Court to expedite the trial and if possible to conclude the same within a period of six months from the date of framing of charge and liberty was granted to the petitioner to renew his prayer for bail if the trial is not concluded within the said period. Learned counsel further submitted that not a single witness has been examined so far and therefore, the petitioner's bail application may be favourably reconsidered.

Learned counsel for the State opposed the prayer for bail.

Status report was called for as per order dated 26.08.2022 and the learned trial Court has furnished the same vide letter dated 07.09.2022 from which it appears that the case was posted to 20.09.2022 for supply of police papers.

Considering the submissions made by the learned counsel for the respective parties and the slow progress of trial, while not inclining to release the petitioner on bail on merit, but taking into account the period of detention of the petitioner in judicial custody, I am inclined to release the petitioner on interim bail for a

period of three months from the date of release and the petitioner shall surrender before the learned trial Court immediately on expiry of the three months period.

For the above period, let the petitioner be released on interim bail in the aforesaid case on furnishing bail bond of Rs.50,000/-(rupees fifty thousand) with two local solvent sureties each for the like amount to the satisfaction of the learned Court in seisin over the matter with further terms and conditions that while on interim bail, the petitioner shall not try to come in contact with any of the prosecution witnesses or tamper with the evidence, he shall not indulge in any criminal activities and he shall appear before the learned trial Court on each date on which the date would be fixed for trial.

Violation of any terms and conditions shall entail cancellation of interim bail.

Accordingly, the BLAPL is disposed of.
