The Tribunal shall consider the application of the petitioners and endeavour to deal with the suit expeditiously.

3. If, in spite of filing an application, the suit is not proceeded further and decided within a reasonable time, then liberty to the petitioners to move this Court afresh.

4. Writ petitions are disposed of. No costs.
