ORAL JUDGMENT :- (Per V K Jadhav, J.)

1. The missing person Shrimant Yadavrao Rajapure is now produced before us by API Shri Mahadev Kisanrao Dhakane, Beed City Police Station, District Beed. The learned APP has placed before us the report of the concerned police Station. API Mahadev Kisanrao Dhakane is present before us. We have gone through the statement of the missing person Shrimant Yadavrao Rajpure recorded by police. As per his statement, he was illegally detained by one Appa Dwarku Fartade and Arjun Tukaram Tule in connection with some money transaction. He was found in the premises of Sahyadri Co-operative Sugar Factory Limited. Learned APP submits that he was in the custody of one Appa Dwarku Fartade and Arjun Tukaram Tule. The learned APP submits that, Crime no.43 of 2022 for the offence punishable u/s 365, 344 of the IPC has already been

registered against those persons at Beed City Police Station and after recording the statement of missing person Shrimant Yadavrao Rajpure, investigation is now being carried out.

2. We have also interacted with the said person Shrimant Yadavrao Rajpure. He has stated in terms of his statement recorded by the police. His age is about 55 years.

3. In view of the same, he shall be set at free, forthwith.

4. The rule of the Habeas Corpus stands discharged. Criminal writ petition is accordingly disposed off.
