1. All these Civil Applications are filed by the State Cooperative Election Officer for seeking extension of time by four months for conducting elections of the Village Level Credit Cooperative Societies.

2. We are informed that out of 18000 elections that are to be conducted, the applicant authority has completed elections in 13913 societies till 09.06.2022. The process for holding elections is continued in the remaining 2587 societies. As 1502 societies are not cooperating by depositing election expenses and by tendering the list of voters, the authorities have appointed the authorized officers to complete the said process so as to facilitate the holding of elections. We appreciate the efforts taken by the applicant authority.

3. In view of the above, these Civil Applications are allowed by extending time by four months, effective from 01.05.2022.
