1. Criminal Appeal No. 19/2001 :

The report of the police dated 27.09.2022 shows that out of seven Respondents, now only Respondent No.2 i.e. Bhanudas Jagannath Lamjane is alive. Appeal against Respondents, except Respondent No.2, stands abated. The Criminal Appeal No. 19/2001 be placed on board on 02.12.2022.

2. Criminal Appeal No. 21/2001 :

The report of the police dated 27.09.2022 shows that all Respondents are dead. Hence the Criminal Appeal No.21/2001 stands abated.

3. Criminal Appeal No. 22/2001 :

The report of the police dated 27.09.2022 shows that all Respondents are dead. Hence the Criminal Appeal No.22/2001 stands abated.

4. Criminal Appeal No. 24/2001 :

It is reported that Respondent No.1 – Baswant Jagannath Lamjane is dead. Hence Appeal against him, stands abated. Respondent No.2 – Bhanudas Jagannath Lamjane is alive. Therefore, the Criminal Appeal be placed on board on 02.12.2022 to the extent of Respondent No.2.

5. Criminal Appeal No. 25/2001 :

The report of the police dated 27.09.2022 shows that the Respondent – Motisingh Tulijaramsing Gahalot, is dead. Hence the Criminal Appeal No.25/2001 stands abated.

6. Criminal Appeal No. 29/2001 :

The report of the police dated 29.09.2022 shows that the Respondent – Janabai Baburao Avate, is dead. Hence the Criminal Appeal No.29/2001 stands abated.

7. Criminal Appeal No. 30/2001 :

The report of the police dated 29.09.2022 shows that the Respondent – Chandarrao Abarao Sonwane, is dead. Hence the Criminal Appeal No.30/2001 stands abated.

8. List the Appeal No.19/2001 with Appeal No.24/2001 on board on 02.12.2022.

9. In Appeal Nos. 19/2001 and 24/2001, Mr. Jadhav was appointed as a lawyer to represent the Respondents through Legal-Aid. He stands discharged. He shall be entitled to Rs.5000/- to be paid by the High Court Legal Services Sub-Committee for his assistance to this Court.
