ORDER

01. Having regard to the reasons mentioned in the applications and as the parties have arrived at amicable settlement, it is desirable to condone

the delay. The delay stands condoned. The Civil Applications for condonation of delay in respective matters stand disposed off. Office to register the appeals.

02. These appeals are placed before us in today's Lok Adalat. Mr. M.B. Bothikar, Tahsildar, Umri, Dist.Nanded is present.

03. Mr. Yadav, learned AGP submits that above numbered group of appeals is squarely covered by Government Resolution No. Sankirna-2014/pra.kra4/Bham-1/A-4 dated 03.11.2016 with Government Corrigendum dated 23.02.2017 and 13.08.2018 to the said Government Resolution. Hence, this group of appeals can be withdrawn as per the policy decision taken by the Government of Maharashtra. Accordingly, the State is withdrawing these appeals.

04. The learned AGP states that entire amount in these appeals has been deposited in the Reference Court. The respondents-original claimants are at liberty to withdraw the amount.

05. However, before disposing off the appeals, it is further clarified that in case the amount is not deposited as per the award, the State Government undertakes to deposit the said amount within a period of one year in the concerned Reference Court. If the amount is not withdrawn by the claimants/respondents, same is allowed to be withdrawn and office to allow withdrawal. If the said amount is not deposited, the claimants are at liberty to

withdraw the same after depositing the amount.

06. The First Appeals stand disposed of as withdrawn.

07. No order as to costs.

08. The court fee refund certificate be issued as per the provisions under the Maharashtra Court Fees Act, 1959.

09. In view of withdrawal of the appeals, pending civil application/s, if any, stand disposed of.
