1. Heard Mr B.R. Survase, learned counsel for the applicants/acquiring body.
2. Issue notice to the respondents. Mr D.M. Kakade, learned counsel waives notice for original claimants/respondents.
3. Heard Mr B.R. Survase, learned counsel for the applicants/acquiring body and Mr D.M. Kakade, learned counsel for the original claimants on the point of condonation of delay.

4. The delay ranges in between 1510 days to 1596 days.
5. Mr B.R. Survase, learned counsel for the applicants submits that the delay was caused to complete the official formalities and to obtain sanction from the concerned department. There was no intentional delay on the part of the applicants. He therefore, urged to condone the delay.
6. Mr D.M. Kakade, learned counsel for the claimants strongly opposed to condone the delay.
7. For the reasons stated in the application for condonation of delay para Nos. 5 to 7 and in the interest of justice, the delay needs to be condoned.

- (I) The applications are hereby allowed in terms of prayer clause (A) and (B).
- (II) The Registry to make scrutiny of the appeals as per procedure and thereafter, those be numbered and placed before the Court for admission.
- (III) The civil applications are accordingly disposed of.
