By issuing a writ of Mandamus or any other appropriate writ, order or direction as the case may be; the Chief Executive Office, Zilla Parishad, Ahmednagar may be directed to hear and decide the representation dated 28.09.2022 forwarded by the petitioner for seeking transfer within a 30 Kms. from the working place of his spouse, in Parner Taluka.”

“A. By issuing a writ of Mandamus or any other appropriate writ, order or direction as the case may be; the Chief Executive Office, Zilla Parishad Ahmednagar may be directed to hear and decide the representation dated 13.10.2022 forwarded by the petitioner for seeking transfer within a 30 Kms. from the working place of his spouse, at Shevgaon Taluka, Dist Ahmednagar.”
