PER COURT:-

1. Civil Application No. 316/2020 is filed for bringing legal heirs of applicant – Vaijanta on record.
2. There is a delay of 50 days in filing this application. Learned counsel for respondent opposes the application.
3. The Division Bench of this Hon'ble High Court in *Keshao Kawadu Maral and another Versus State of Maharashtra*, reported in **2005 (supp.) B.C.R. 226**, condoned the delay of six years in filing the application of bringing legal heirs on record, relying on Supreme Court

judgment of Sardar Amarjit Singh Kalra (Died) by LRs and others Versus Pramod Gupta (Smt.) Dead) by Lrs. And others, reported in (2003) 3 SCC 272.

4. Relying upon the above judgments and for the reasons stated in the application, civil application No. 316/2020 is allowed in terms of prayer clause 'B' and 'C'. The Civil Application stands disposed off. Abatement stands set aside.

5. Amendment to be carried out within a period of six (06) weeks from today.
