1. All these petitioners, by these petitions, seek to challenge the orders dated 27/01/2022 delivered by the Deputy Registrar, Co-Operative Societies, Karad, Taluka Karad,

District Satara. By the impugned orders, their appeals under Section 152(A) of the Maharashtra Co-Operative Societies Act, 1960 have been disallowed and the rejection of their nomination forms by the Returning Officer, has been sustained.
