2022 respectively. Thereafter, both the parties have been directed to try for the settlement of their dispute, by the Hon'ble High Court, Bombay in Criminal Writ Petition No. 3831 of 2022."

- 3.** Copy of the consent terms are taken on record and marked "X" for identification.
- 4.** In view of the above, both Misc. Civil Applications are disposed of.
- 5.** Stay granted vide order dated 25.08.2022 stands vacated. Parties to take appropriate steps.
- 6.** In view of the judgment dated 11.12.2021 passed by the Supreme Court in the case of *Amit Kumar v/s. Suman Beniwal* reported in 2022(2) Mh.L.J. 1, the period of six months for grant of decree of divorce by mutual consent stands waived.
