1. Heard learned counsel for applicants. It is submitted that Interim Application Nos.690 of 2019 and 689 of 2019 are civil side matters and wrongly tagged with criminal side matters. It is directed that these two matters be de-tagged from the criminal revision applications.

2. The revision applicant in Revision Applicant No.647 of 2018 has expired on 4th December 2021. The death certificate is annexed to the application. Interim Application Nos.2191 of 2022 and 2192 of 2022 are preferred for bringing on record legal heirs of applicant.
