1. Heard learned counsel for the parties.
2. The petitioner-Hetal Manish Bhawani and the
respondent-Manish Narsi Bhawani are personally present in
the Court. Devi, the daughter of the Hetal and Manish, is

also personally present. The parties have tendered the consent terms in Writ Petition No.11999 of 2022, which are taken on record and marked as **Exhibit 'X'** for identification.

3. The petitioner-Hetal says that the consent terms have been explained to her in Gujarati by Advocate Namita Mestry, learned advocate assisting learned counsel for the petitioner.

4. I have interacted with the parties. They say that they have decided to settle the matter in terms of what is stated in the consent terms and that they will abide by the terms of the consent terms. Statements are accepted as an undertaking to this Court.
