1. Perused the order dated 17th July, 2014 passed by this Court in Civil Application No. 2266/2014 in First Appeal No. 1522/2013. By that order, Applicants were allowed to withdraw 75% of remaining compensation by furnishing the solvent security to the satisfaction of the trial Court/ Reference Court.
