1. The entire group has been tagged by an order of the Hon'ble the Chief Justice. In three matters, though transferred to the Principal Seat from the Aurangabad Bench, papers have not yet been received. These are Writ Petition No. 11111 of 2021, Writ Petition (St) No. 27238 of 2021 and Writ Petition (St) No. 27236 of 2021. The Registry is requested to urgently call for these papers from Aurangabad and to have them renumbered here if necessary.
