2. In the light of Circular No.17 of 2019, the appeal is disposed of as involving low tax effect.

3. However, we observe that in case, the Revenue finds for some reason that the appeal was not supposed to have been withdrawn in the light of the Circular, it would be open to the Revenue to file an application/praecipe seeking restoration of the appeal to be decided on its own merits.
