1. By this Interim Application, the applicants seek leave to

amend the writ petition as per the draft amendment annexed at Exhibit "C" of the Interim Application. Mr.Khandeparkar, learned counsel for the applicants tenders the draft amendment and seeks amendment to the draft amendment appended at Exhibit "C" to the Interim Application and seeks leave to amend the writ petition in terms of the draft amendment tendered across the bar.

2. Learned counsel for the applicants seeks to place on record the subsequent events that transpired after filing of this writ petition.
