1. The present Interim Application seeks a prayer of expeditious hearing and disposal of Writ Petition No.1736/2019.

2. The challenge in the Writ Petition is to an order dated 09/03/2018 passed by Respondent No.1-The Deputy Collector (GAD), Mumbai City, Mumbai.

3. The Petitioner is the daughter-in-law of Respondent Nos.2 and 3. It seems that the dispute is amongst the family members. It is suggested to the respective Counsel as to whether their respective clients would be agreeable to explore the possibility of resolving this dispute by mediation, both of them fairly agreed for the same.
