This Criminal Original Petition has been filed seeking a direction to file a final report in Crime No.6/AC/2018, pending on the file of 2nd respondent police.

2. The petitioner is sole accused. The crime came to be registered for the alleged offences under Sec.7 and 13(1)(d) r/w 13(2) of Prevention of Corruption Act, 1988 in Crime No.6/AC/2018. Even though the F.I.R. was registered on 07.02.2018, for more than 4 years, the 2nd respondent did not complete the investigation and file a final report. In those circumstances, the present petition has been filed seeking a direction to file a final report.
