2. He would further submit that the order copy was made ready on 16.12.2021, however, since the Courts were closed for Christmas vacation, the petitioner was unable to file the petition seeking for extension of time and the petition has been filed immediately on the date of reopening the Court.

3.Considering the facts and circumstances of the case, time granted by this Court in Crl.M.P.No.13026 of 2021 by order dated 15.12.2021 is extended by further period of two weeks from today.
