Without expressing any opinion on merits of the writ petition, the first respondent is directed to conduct enquiry on the representation of the petitioner dated 03.09.2021, after issuance of notice to the petitioner and the counter parties, if any, by giving them an opportunity of hearing and pass order to issue patta in respect of the property comprised in Ayan Punjai Survey No.532/1B, Thuringikuppam Village, Polur Taluk, Tiruvannamalai District on merits and in accordance with law within a period of six weeks from the date of receipt of a copy of this order.

4. With the above direction, the writ petition is disposed of. No costs.
