The representation has been filed before R1, and, in the light of there being no objection to the relief sought for by the petitioner, as expressed by learned counsel for the respondents, mandamus is issued to R1 to dispose representation dated 30.11.2020 taking the assistance of R2 and R3 as well or any other official respondent that may be necessary, hear the petitioner as well R4 or any other private party that may be necessary and pass orders thereupon, in accordance with law and other rules and regulations within a period of twelve weeks from today.

4. This writ petition is disposed in the above terms.
