Writ Appeal filed under Clause 15 of Letters Patent to set aside the order made in M.P.No.1 of 2011 in W.P. No. 11159 of 2011, dated 26.11.2015.

Prayer in M.P.No.1 of 2015 in W.P.No.11159 of 2011 is filed praying to pass an order of injunction restraining the Second respondent from convening the 88th and 89th Annual General Body Meeting till 1st Respondent classify and passes the order afresh.

Prayer in W.P.No.11159 of 2011:

Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, directing the 1st respondent to reconsider and amend the order dated 31.03.2011 by including the names of B.Ramachandra Adityan Pankajam, Kannan Adityan, Geetha, Prem Vetti, K.P.K. Kumaran (his family members) and his men viz. N.C.Pandian K.Lingakumar, S.Vijayaragavan, M.Selvaraj, P.Rajan and 194 individuals and characterize them as forming part of the group and other errors pointed out by the petitioner in his representation in the order of the 1st respondent.
