These Writ Petitions have been filed for the issuance of Writ of Mandamus, directing the first respondent to conduct enquiry on the petitioners' statutory appeal dated 05.10.2021 filed in (SR) No 37950 of 2021 and in (SR) No 37951 of 2021 under Rule 17 of the TN Document Writers License Rules, against impugned order passed by the second respondent in ref No.Na.Ka.No.2099/A2/2021 and in ref No.Na.Ka.No.2099/A2/2021-2 - ie District Registrar, Tindivanam, Dated 29.07.2021 in cancelling the petitioners' document writer license bearing No.26/TVM/2000 and bearing No.B19/TVM/1999 and dispose of the same within a time frame as may be fixed by this Hon'ble Court.

2. Heard Mr.R.Veeramani learned counsel appearing for the petitioners and Mr.Yogesh Kannadasan, learned Special Government Pleader appearing for the respondents.

3. The petitioners filed appeals as against the order passed by the second respondent dated 29.07.2021 before the first respondent by the statutory appeals dated 05.10.2021 and it is pending in (SR) No.37950 of 2021 and in (SR) No.37951 of 2021.

Considering the above, the first respondent is directed to issue notice to the petitioners and the counter parties if any and conduct enquiry after giving an opportunity of hearing to them and pass orders on merits and in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.
