Petition filed under Article 226 of the Constitution of India to issue a writ of Habeas Corpus call for the entire records relating to petitioner's son detention under Tamil Nadu Act 14 of 1983 *vide* detention order dated 22.12.2021 on the file of the second respondent herein made in proceedings D.O.No.123/2021 - C2 and quash the same as illegal and consequently direct the respondents herein to produce the said petitioner's son viz., Sabarinathan, son of Varatharajan, aged 21 years, before this Court and set the petitioner's son at liberty from detention, now petitioner's son detained at the Central Prison, Vellore.
