ORDER

- (1) This contempt petition is filed by the petitioner alleging willful disobedience of the order dated 23.06.2021 made in WP.No.13113/2021 by the respondents herein.
- (2) While disposing of the writ petition, this Court passed an order directing the respondents to consider the representation of the petitioner and to dispose of the same.
- (3) Pursuant to the order passed by this Court, a further representation was submitted by the petitioner. Since the respondents did not pass any order on the representation of the petitioner, the above contempt petition is filed.
- (4) Mr.V.Jeevagiridharan, learned Additional Government Pleader on instructions submitted that the 2nd respondent / Tahsildar, Uthukottai Taluk, vide proceedings dated 05.01.2022 in Na.Ka.No.357/2021/A5, disposed of the petitioner's representation dated 20.02.2020 and the subsequent representations.
- (5) Having regard to the nature of direction of this Court, this Court is of the view that the representation of the petitioner has been duly considered by the 2nd respondent / Tahsildar, Uthukottai Taluk.

(6) Hence, this Contempt petition is closed recording compliance. It is open to the petitioner to challenge the order of the 2nd respondent dated 05.01.2022.
