2. Heard Mr.K.Raja, learned counsel appearing for the petitioner, Mr.V.Jeevagiridharan, learned Additional Government Pleader appearing for the respondents 1 and 2 and Mr.L.S.M.Hasan Fizal, learned Additional Government Pleader appearing for the third respondent.

Without expressing any opinion on the merits of the writ petition, the first respondent is directed to issue notice to the petitioner and counter parties if any and conduct enquiry, after giving an opportunity of hearing to them, pass orders on merits and in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.

4. With the above directions, this writ petition is disposed of. Consequently, connected Miscellaneous petition is closed. There shall be no order as to costs.
