PRAYER:

This Writ Petition filed under Section 226 of Constitution of India, pleaded to issue a Writ of Declaration declaring the Land Acquisition proceedings relating to petitioner lands of an extent of 0.72.0 Hectares equivalent to 1 Acre 78 Cents in Survey No. 798/1 of Thanthoni Village Karur Taluk and District initiated by the 4(1) notification bearing G.O.Ms.No.446 Revenue dated 3.6.1998 published in the Tamilnadu Government Gazette Part-II Section 2 dated 4.6.1998 and covered by the Award bearing No.6/99 dated 6.7.1999 as lapsed.
