ORDER

The main grievance of the petitioner is that the First information Report has been registered under Sections 147, 447, 427 of IPC and the necessary charges have not been included in the said First Information Report. Hence, this criminal original petition filed seeking for a direction to the respondent police to include the necessary offences by conducting the further investigation.

2. On the other hand, the learned Additional Public Prosecutor produced an Alteration Report sent by Sub-Inspector, Kadampuliyur Police Station, Kadampaliyur dated 15.12.2021, wherein, it is inter alia stated that after thorough investigation, the offences have been altered from Sections 147, 447, 427 of IPC to 147, 148, 447, 427, 294 (b), 354, 506 (ii) of IPC. the learned counsel for the petitioner submitted that since the charges have been altered, no further is required to be passed.
