Prayer: Writ petition filed under Article 226 of the Constitution of India praying for issuance of a Writ of Certiorarified Mandamus to call for the impugned publication of the Advertisement dated 22.12.2021, inviting applications by the 2nd respondent to fill up the 16 posts of Village Assistants and quash the same, consequently direct the 2nd respondent to issue a fresh publication by disclosing the names of the village, vacancy position, reservation on community roster the criteria and procedure to be followed in selection to the Village Assistants.
