Petition filed under Article 226 of the Constitution of India to issue a writ of Habeas Corpus call for the entire records in connection with the order of detention passed by the second respondent dated 30.11.2021 in D.O.No.111/2021-C2 against the petitioner's husband Alliraja, male, aged 33 years, S/o.Allimuthu , who is confined at the Central Prison, Vellore and set aside the same and direct the respondents to produce the detenu before this Court and set him at liberty.
