Prayer: Writ petition filed under Article 226 of the Constitution of India seeking to issue a Writ of Certiorarified Mandamus, to call for the records of the 5th respondent in connection with the impugned order passed by him in Na.Ka.No.1548/2020/R3 dated 30.11.2021 and quash the same and

The learned Special Government Pleader would submit that since the petitioner has not complied the earlier order passed by the 5th respondent, the aforesaid impugned order dated 30.11.2021 has been passed by the 5th respondent. However, if any such representation was received by the 1st respondent, the same will be considered on merits and in accordance with law.

5. Considering the facts and circumstances of the case and also considering the limited scope of prayer, without expressing any opinion on merits, this court is inclined to direct the 1st respondent to consider the petitioner's representation dated 03.12.2021 and pass appropriate orders on its own merits and in accordance with law, as expeditiously as possible, within a period of twelve weeks from the date of receipt of a copy of this order. Till such time, the aforesaid impugned order shall be kept in abeyance.

6. With the above direction, this writ petition stands disposed of. No costs. Consequently, connected miscellaneous petitions are closed.
