O R D E R

The Criminal Original Petition has been filed to quash the First Information Report in Crime No.1018 of 2019 on the file of the respondent police, for the offences punishable under Sections 147, 294(b), 323, 506(i) of IPC and Section 4 of Tamil Nadu Prohibition of Harassment of Women Act, 2002.

2.The case is still at the stage of investigation. By passage of time, the parties have decided to bury their hatchet and compromise the dispute amicably among themselves.

3.A Memorandum of Understanding has been filed before this Court, which has been signed by the first petitioner and the second respondent's daughter (1st Petitioner's Wife). This Court also enquired both the parties and satisfied that the parties have come to an amicable settlement between themselves.



4. The relevant portion of the joint memorandum of Understanding is extracted hereunder :-

(iv) The parties agree that the divorce granted by and the VI Additional Family Court, Chennai are valid and both parties agree not to reopen the above proceedings and both shall not file any other case, petition or complaint before any police, or other authorities or before any Court except as stipulated in this deed of MOU.

6. Accordingly, this Criminal Original Petition stands allowed and as a sequel, the proceedings in Crime No.1018 of



2019, on the file of the first respondent police, is quashed and the joint compromise memo shall form part and parcel of this order.
