COMMON ORDER

These Civil Revision Petitions have been filed as against the order dated 21.04.2009 passed in C.M.P.Nos.21 and 22 of 2008 in A.S.No.412 of 2005, on the file of the learned Appellate Fast Track Court-II, Chennai, thereby dismissed the petitions to condone the delay of 708 days and to implead the legal representatives of the deceased respondents.
