Petition filed under Article 226 of the Constitution of India to issue a

writ of Habeas Corpus call for the entire records relating to the petitioner's father detention under Tamil Nadu Act 14 of 1982 *vide* detention order dated 28.12.2021 on the file of the second respondent herein made in proceedings D.O.No.129/2021-C2 and quash the same as illegal and consequently direct the respondents herein to produce the said petitioner's father viz., Devendiran, son of Duraisamy, aged 43 years, before this Court and set the petitioner's father at liberty from detention, now the petitioner's father detained at the Central Prison, Vellore.
