The Petitioners have filed this petition seeking to modify the condition in para 6(d) imposed by this Court in Crl.O.P.No.982 of 2022 for the offences punishable under Sections 147, 148, 294(b), 323, 324 & 307 of IPC r/w 294(b), 323, 324 & 307 of IPC, in Crime No.713 of 2021, while granting bail.



2. The learned Counsel appearing for the petitioners submitted that the petitioners are complying with the conditions from 14.01.2022 till date and it is very difficult them to stay and accommodate in Cuddalore, since, the petitioners being a native of Tiruvannamalai District and they are sole bread winner of the family. Hence, the present modification petition has been filed..

3.The learned Additional Public Prosecutor submitted that the petitioners are complying with the conditions regularly.

4.Considering the facts and circumstances of the case, the condition already imposed by this Court is modified and the petitioners are directed to appear before the respondent police on every Monday at 5.00 p.m.,until further orders. This petition is ordered.
