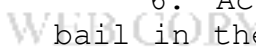
O R D E R

The petitioner, who apprehends arrest at the hands of the respondent police for the alleged offences under Sections 379, 430 of IPC and Section 21(1) of M.M.R.D Act in Crime No.38 of 2022, seeks anticipatory bail.

2. The case of the prosecution is that the respondent on their routine raid found a Bullock cart carrying 1/4 unit of sand. After seeing the respondent, the persons ran away. Hence the complaint.

3. The learned counsel appearing for the petitioner submitted that the petitioner has not committed any offence as alleged by the prosecution and he has been falsely implicated in this case. Hence, he prays for grant of anticipatory bail.

4. The learned Additional Public Prosecutor appearing for the respondent submitted that the petitioner illegally transported 1/4 unit of sand without any permission and no previous case pending against the petitioner. However, he vehemently opposed to grant anticipatory bail to the petitioner.
