1st respondent would submit that the facts of the case are similar to the facts covered under the Judgment referred above.

5.The facts of this case is similar to the facts covered by the Judgment of this Court reported in 2018 2 LW (Cr1) 606 [Jeevanandham and others vs. The Inspector of Police Velayuthampalayam Police Station, Karur District] dated 20.09.2018 and in case of Sri Raja vs Inspector of Police, Sivakasi Town Police Station Virudhunagar District and other in batch of cases in Cr1.O.P(MD) No.7922 of 2019 dated 30.08.2019.
