Order : This petition coming on for orders upon perusing the petition and the filed in support thereof and upon hearing the arguments of M/S.M.MADHU PRAKASH, Advocate for the petitioner, and of MR.S.UDHAYA KUMAR, Govt. Advocate (Crl. Side) on behalf of the Respondent, the court made the following order:-

This petition is filed to modify the order in Crl.OP.No.17379 of 2021.

2.This Court vide order dated 27.09.2021, granted bail to the petitioner on condition that the petitioner shall deposit a sum of Rs.75,00,000/- (Rupees Seventy Five Lakhs only) to the credit of Cr.No.90/2021.

3. Today, when the matter is taken up for hearing, the learned counsel for the petitioner submitted that the petitioner is an innocent and he is no way connected in this case. The petitioner is only an employee and he is not a beneficiary and he is not in a position to deposit such a huge amount. Hence, the learned counsel prays to modify the condition.



4. In view of the backdrop, the earlier condition imposed by this Court is on the basis of the petitioner's instructions and his own volition. Now, this modification petition has filed on the different ground, which is not permissible. Hence, this petition for modification of the condition imposed by this Court dated 27.09.2021 in Crl.OP.No.17379 of 2021 does not acceptance and accordingly, this miscellaneous petition is dismissed.
