2. The learned counsel appearing for the petitioners submitted that the 1st petitioner was infected with COVID 19 from 13.01.2022 admitted in hospital and later he was discharged and all the petitioners were in home quarantine. Hence, they could not execute the sureties in time.

3. Heard the learned Government (Crl.Side) appearing for the respondent police.

Considering the facts and circumstances of the case and the submission made by the learned counsel for the petitioners that the petitioners were not complied the condition imposed by this Court, otherwise the reason stated by the petitioners in respect of modifying the condition is not satisfactory, this Criminal Miscellaneous Petition is dismissed.
