To an grant ad-interim injunction restraining the Respondents from preparing and publishing the panel of Additional Superintendent of Police / Additional Deputy Commissioner of Police fit for Promotion as Superintendent of police / Deputy Commissioner of police of following the Roaster system of fixation of seniority, pending disposal of the present writ petition.

2. WMP No.10398 of 2020 IN WP.No.8602 of 2020
To permit the petitioners to file a single writ petition and thus render Justice.

3. WMP No.10399 of 2020 IN WP.No.8602 of 2020
To grant an order of ad-interim stay of the panel of Additional Superintendent of police/ Additional Deputy Commissioner of Police fit for promotion as superintendent of police/ Deputy Commissioner of

Police published in G.O.Ms.No. 229 dated 09.06.2020 Home (Police 1A) department by illegally following the Roaster system of fixation of seniority, pending disposal of the above Writ Petition.

5. WMP No.8579 of 2021 IN WP.No.8602 of 2020

To modify the Interim Order of Status quo passed by this Hon'ble Court in WMP. 10398 and 10399 of 2020 in W.P.No. 8602/2020 dated 15.07.2020 exempting the Petitioner from the scope of the order.

Order : These petitions coming on this day for hearing upon perusing the petitions and the respective affidavits filed in support thereof and upon hearing the arguments of MR.MANI SHANKAR, Senior Counsel for M/S.A.ASHWIN KUMAR, Advocate for the Petitioner in WMP.2648, 10398, 10399/2020 and of M/S.ASHOK MENON, Advocate for the Petitioner in WMP.8573, 8579 and 8580/2021 and of MR.T.ARUN KUMAR, Additional Government Pleader for the 1 and 2 Respondents IN WMP.No.2648/2020, WMP.10398/2020 and WMP.10399/2020 and of M/S.HEMA, Senior Counsel for the 3rd Respondent in WMP.2648/2020, WMP.10398/2020, WMP.10399/2020 and of M/S.G.SANKARAN, Advocate for 5, 6 and 9 Respondents in WMP.2648/2020 and 11 to 19 Respondents in WMP.10398, 10399/2020 and of 4, 7, 8, and 10 and 11 Respondents not appearing either in person or by an Advocate in WMP.2648/2020 and 4 to 10 Respondents not appearing either in person or by an Advocate in WMP.10398, 10399/2020 the court made the following order:-

WMP 2648 of 2020 in WP 2268 of 2020 has been filed to grant interim injunction restraining the respondents from preparing and publishing the panel of Additional Superintendent of Police/Additional Deputy Commissioner of Police fit for promotion as Superintendent of Police/Deputy Commissioner of Police, following the roster system of fixation of seniority, pending disposal of the writ petition.

WMP No.10399 of 2020 in WP.8602 of 2022 has been filed to grant interim stay of the panel of Additional Superintendent of Police/Additional Deputy Commissioner of Police fit for promotion as superintendent of Police/Deputy Commissioner of police published in G.O.Ms.No.229 dated 09.06.2020 Home (Police 1A) department by illegally following the roster system of fixation of seniority, pending disposal of the writ petition.

WMP No.10398 of 2020 in WP.8602 of 2020 has been filed to permit the petitioners to file a single writ petition.

2. Today, when the matters are listed for hearing, the learned counsels to both the parties have appeared. Mr.Mani Shankar, learned Senior Counsel appearing for the petitioners placed the Government Order in G.O.282 (Home Department) dated 09.06.2022 before this court and submitted that the petitioners as well as the private respondents have been temporarily promoted as Superintendent of Police and posting orders have also been issued to them. It is also brought to the notice of this Court that the temporary promotion would be subject to the outcome of the writ petitions.

3. Inview of the above, this court is of the view that the issues involved in the writ petitions as well as the issue with regard to the temporary promotion to the cadre of Superintendent of Police can be decided at the time of final hearing of the writ petition and hence, there is no need to adjudicate further in writ miscellaneous petitions and to keep pending till the disposal of the writ petition.

4. Accordingly,

i) The writ miscellaneous petitions in WMP No.2648 of 2020 in WP.2268 of 2020; and WMP No.10399 of 2020 in WP.8602 of 2020 are closed.

ii) WMP No.10398 of 2020 in WP.8602 of 2020 is allowed, subject to the payment of separate Court Fees.

iii) Consequently, though the writ miscellaneous petitions in WMP No.8573, 8579 and 8580 of 2021 in WP.8602 of 2020 are not listed today, the same are closed, since they have been filed to modify the interim order of Status-quo passed in WMP No.10399 of 2020 in W.P.No.8602 of 2020 dated 15.07.2020.
