5. Further from the notice sent to the petitioner, it is seen that the notice is without any particulars except for informing that A2 has been arrested and A1 has been filed an anticipatory bail petition. The petitioner is asked for details, which is



yet to be produced. Further it is seen that on 12.01.2022, the petitioner had lodged a complaint stating about the threat and abuse. The said Ashwin Kumar and her friend Sofia called for enquiry. For which the said Ashwin Kumar had lodged a complaint though CSR assigned no action has been taken so far. Investigation seems to be on its own pace.

6. In view of the same, investigation is to be transferred to the file of the Assistant Commissioner of Police, who shall investigate both the case in Crime Nos.25 of 2021 and 356 of 2021. The Inspector of Police, Chitlapakkam Police Station is directed to hand over the entire case diary of the CSR.No.27 of 2022 to the Assistant Commissioner of Police, Tambaram, likewise, the Inspector of Police, Chitlapakkam and Inspector of Police, All Women Police Station, Tambaram are also directed to handover the case diaries in Crime Nos.25 of 2021 and 356 of 2021 to the Assistant Commissioner of Police, Tambaram. The Commissioner of Police, Tambaram is directed to assign an appropriate officer in the rank of Deputy Commissioner of Police, CCB, Tambaram to conduct investigation in both the cases especially Ms.Subbulakshmi, Deputy Commissioner of Police, CCB, Tambaram to investigate the case and file the final report. The above said investigation is to be completed within a period of six months from the date of receipt of a copy of this order.

7. With the above direction, this Criminal Original Petition stands disposed of.
