This Criminal Original Petition has been filed to call for the records relating to the Crime No.5 of 2016 on the file of the 1st respondent police and to quash the same as far as the petitioners are concerned.

Based on the complaint given by the defacto-complainant, the first respondent police has registered a case in Crime No.5 of 2016, before the All Women Police Station, Coimbatore, for the alleged offence under Sections 498(A), 420 and 109 of I.P.C against her husband, mother-in-law, sister-in-law and brother-in-law.
